Norman McKee of Canada Post provided us with information about its fledgling University Mail Incentive Program. They have been working with a number of institutions on various possible applications of interest to universities in general, and we were impressed by two of the objectives—cheaper rates and potentially faster service. They are also a rallying point in that some movement has been initiated with Revenue Canada for the production of the Education Deduction Certificates!

## Le message du président

Au lieu d'essayer de vous tenir des propos inspirés, j'ai jugé préférable de vous faire part de ce qui s'est passé à la réunion récente du Comité exécutif de l'ARUCC qui a eu lieu à Ottawa le 19 novembre. L'ordre du jour comportait deux exposés, l'un de la Société canadienne des postes et l'autre de Statistique Canada qui a également invité le Bureau à déjeuner.

Norman McKee de la Société canadienne des postes nous a fourni des données sur son nouveau programme incitatif pour le courrier des universités. La Société canadienne des postes collabore avec un certain nombre d'établissements à diverses applications possibles susceptibles d'intéresser les universités en général, et nous avons été frappés par deux des objectifs, une baisse des tarifs et peut-être même un raccourcissement des délais de livraison. Avec Statistique Canada, nous avons discuté de divers éléments d'information et de la possibilité de modifier les ensembles de données nouveaux ou existants. Nous avons également abordé la possibilité que Statistique Canada participe à la conférence de juin à Victoria.

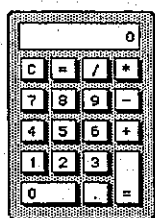

## 1992 CAUBO Quality and Productivity Awards

A record number of 72 submissions were received for the sixth annual awards program. The prize winners and two honourable mentions are as follows:

Since the 1992 competition was revised to include Quality, in addition to Productivity, the impact of improvements in quality of service, enhancement of institutional image, better working conditions, etc, were included as criteria for judging the 1992 applications. The measurement of cost savings and/or revenue generation, often in conjunction with quality factors, was also taken into account in the selection process. It is interesting to note here that the innovative

ideas, initiated by the 31 participating universities, result in annual savings or recovery of almost \$7 million.

In addition to an increased recognition of the quality of service, another feature which applies to seven of the entries is the involvement of other institutions. Not surprisingly in light of current concerns for violence in the world, four of the submissions, including two of the six winners, are involved with safety programs and the quality of life on university campuses. It was also noticed that in many cases the projects indicate a significant review and revision of the operations of whole departments or service areas.

The contribution of the corporate sponsors—the Royal Bank of Canada and Xerox Canada Ltd—is gratefully acknowledged. Significant financial support and invaluable assistance with the selection process was provided. The expertise of these two well-known companies in how to measure and evaluate Total Quality Management (TQM) techniques also complemented the 1992 program. This practical added support provides an ideal opportunity for CAUBO member institutions to work and learn together with these two continuing sponsors in the application of TQM on university campuses.

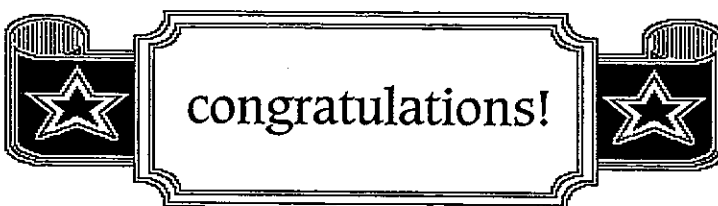

Depuis que le concours de 1992 a été revu de manière à inclure la qualité en plus de la productivité, l'effet des améliorations apportées à la qualité des services, l'amélioration de l'image institutionnelle, de meilleures conditions de travail, etc, ont été ajoutées à la liste des critères qui ont servi à juger les dossiers de candidatures reçus cette année. La mesure des épargnes réalisées et (ou) des revenus générés, très souvent de concert avec les facteurs de qualité, ont également été pris en compte à l'étape de sélection. Il est intéressant de noter que les idées novatrices présentées



ici ont permis aux 31 universités participantes d'épargner ou de générer des revenus pour un montant approchant les sept millions de dollars.

En plus d'une reconnaissance accrue en faveur de la qualité des services, un autre élément qu'il faut mentionner est la participation d'autres établissements, qui s'applique à sept des candidatures présentées ici. Considérant la violence qui nous entoure, il n'est pas surprenant de constater que quatre des candidatures, dont deux des six vainqueurs, font état de programmes de sécurité et de qualité de vie sur les campus universitaires. Aussi, dans de nombreux cas, les dossiers qui nous ont été soumis, révèlent des revues en profondeur des opérations de départements et de services entiers.

Le soutien des commanditaires du secteur privé, la Banque Royale du Canada et Xerox Canada Ltée, s'est avérée un élément important de cette édition du concours et nous les en remercions sincèrement. Ils nous ont apporté un appui financier et administratif et financier pour passer au travers l'étape de sélection; d'ailleurs, pour ce qui est de la mesure et de l'évaluation de la Gestion de la qualité totale (GQT), les compétences reconnues de ces deux sociétés réputées ont été mises à profit au cours de cette édition du concours. Ceci s'est avéré une occasion rêvée d'apprendre plus sur les techniques de gestion de la qualité totale et les établissements membres de l'ACPAU ont appris beaucoup de leur travail en collaboration avec ces entreprises. Cette collaboration leur a permis de bien comprendre les rouages de l'application de la GQT sur les campus universitaires.

## AACRAO gives back

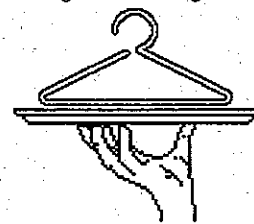

## Inscriptions/registration

La CRÉPUQ vient de publier un aperçu des inscriptions préliminaires dans les universités pour l'automne 1993. La clientèle de plus de 250 000 étudiants, demeure presque inchangée depuis 1992 accusant une diminution de 0.3%. Malgré des inscriptions plus nombreuses à plein temps avec une hausse de 1.6%, et aux cycles supérieures, le total a diminué de 0.3%, le premier cycle a diminué de 1% car le temps partiel accuse une baisse de 3.9%. Les augmentations au deuxième cycle sont de 2.5% et de 6.0% au troisième cycle. Quatre établissements affichent des augmentations entre 1% et 4.2% alors que cinq établissements, dont le réseau de l'Université du Québec, ont connu des baisses entre 0.4% et 5.7%.



The Conference of Rectors (CREPUQ) has released preliminary university enrolment figures for Fall 1993. The student population of more than 250,000 remains virtually unchanged from 1992 with a decrease of 0.3%. There are more full-time and graduate level students whereas the undergraduate level has declined 1%. This is due to a 3.9% drop among part-time students and despite an increase of 1.6% for full-time undergraduates. Increases of 2.5% and 6.0% were recorded for masters and doctoral level students. Four institutions had increases ranging from 1% to 4.2%, and five, including the Université du Québec network, had declines of 0.4% to 5.7%.

## Droits/fees

Le gouvernement du Québec a annoncé son intention de voir les droits de scolarité dans les universités québécoises rejoindre la moyenne nationale. Ces droits, d'environ de 1 500\$ par année en 1993/94, accuse un retard de quelque sept à huit cents dollars vis-à-vis les autres provinces. Reste à savoir quelle échéance sera retenue mais il est évident que si l'objectif visé connaît une tendance à la hausse, il faudra plusieurs augmentations d'envergure pour y arriver. La dernière fois que le ministère a autorisé une hausse, elle se chiffrait à 350\$ par année pendant deux ans. Une hausse additionnelle de 700\$, au cours des deux prochaines années, serait nécessaire pour combler le présent retard d'ici 1995/96 et une autre tranche de 350\$ en 1996/97 pour tenir compte des augmentations qui auront probablement été imposées dans les autres universités pendant de temps



The Québec government has announced its intention to increase tuition fees at provincial universities to the national average. At some \$1,500 per year, they are seven to eight hundred dollars less than in the other provinces. No target date has been set for achieving the objective, but it is clear that, if the national average continues to rise, several substantial increases would be needed in order to catch up. The last time the government allowed fee increases they were of \$350 per year for each of two years. A further \$700 increase over the next two years would be needed to make up the current difference by 1995/96 and a further \$350 in 1996/97 to account for probable increases at other universities in the meantime.

## Stats Canada



Depuis plusieurs années déjà, les universités québécoises transmettent au gouvernement provincial des données informatiques sur leur clientèle. Connue sous le sigle RECU (Recensement des Clientèles Universitaires), la banque de données permet des analyses statistiques et le calcul du financement. Suite à une entente conclue entre le Ministère de l'Enseignement supérieur et de la Science (M.E.S.S.) et Statistiques Canada, le système RECU alimentera dorénavant la banque d'information fédérale sur la population étudiante. Les registraires universitaires intégreront actuellement dans leur système d'inscription les quelques éléments manquants qui leur permettront, une fois transmis à RECU, de répondre aux exigences de Statistiques Canada. La transmission de données RECU-StatsCan évitera aux universités du Québec une double déclaration tant pour les étudiants inscrits que pour les diplômés.



For several years now, universities in Québec have provided electronic data on their students to the provincial government. Known as RECU (for census of university clients) the data bank is used for statistical analysis and grant calculation. As a result of an agreement between Statistics Canada and the Ministry of Higher Education and Science (M.E.S.S.), the RECU system will soon feed data to the federal student data system. University registrars are currently adding the few missing data elements to their registration systems which, when reported to RECU, will allow the StatsCan data requirements to be met. The exchange of data between the two systems will eliminate one level of data reporting for both registrants and graduates.

## Indicateurs de l'activité universitaire/data on university activities



La publication d'un recueil de renseignements sur certaines facettes de l'activité universitaire, une première pour le Québec et pour le Canada, s'inscrit dans une démarche qui vise à rendre compte de l'utilisation des fonds publics mis à la disposition des universités. L'ouvrage contient non seulement des données historiques sur l'ensemble du système universitaire québécois, mais aussi une fiche détaillée pour chaque établissement. Ces fiches traitent de la population étudiante, du personnel enseignant, des diplômes décernés et de la recherche subventionnée et commanditée. Pour la ministre de l'Enseignement Supérieur et de la Science, une telle approche permet à la fois "de rendre plus concrète la présence des universités et de décrire le chemin parcouru depuis le début des années 70". La ministre a insisté sur le fait que les indicateurs, qui présentent des résultats bruts, ne permettent pas de mesurer la qualité ou la performance. "Pour parler de qualité et de performance, il nous faudrait établir des standards auxquels les données brutes seraient comparées. Néanmoins, les indicateurs publiés aujourd'hui constituent le point de départ d'une réflexion plus poussée et d'analyses plus fines". Elle a évoqué l'intérêt d'étudier "les taux de fréquentation par région, les admissions, le taux de passage du collège à l'université, la durée des études, les changements de programmes, les abandons, les collaborations entre les universités pour offrir des programmes conjoints, l'importance des bibliothèques et les coûts par programme et par diplôme décerné".

Voici quelques faits saillants de la publication:

### **L'évolution de la population étudiante**

Entre 1971 et 1991 la population masculine augmentait de 80% alors que l'effectif féminin s'accroissait de près de 325%. Pendant la même période, le taux

d'inscription universitaire pour les 18 à 29 ans est passé de 7.4% à 18.9%. Plus de 50 000 personnes sont diplômées chaque année et 90% d'entre elles trouvent un emploi, mais qui n'est pas toujours lié au champ d'études. 82% des détenteurs de maîtrise trouvent du travail dans leur domaine alors que seulement 73% des détenteurs des doctorats ont le même succès.

### **Le personnel enseignant**

De 2 350 en 1960, le nombre de professeurs d'université est maintenant passé à plus de 8 500. L'âge moyen est passé de 39 ans en 1971 à 47 aujourd'hui. Un poste sur cinq est occupé par une femme.

### **La recherche**

Les sommes consacrées à la recherche universitaire se sont multipliées par quatre entre 1981 et 1991, passant de 141 à 569 millions de dollars. Cette recherche est surtout financée par le gouvernement fédéral (37%), par le gouvernement québécois (20%) et par le secteur privé (32%). Cette dernière source de financement est en forte hausse, puisqu'elle ne représentait que 12% du total en 1981. Les sommes consacrées à la recherche est particulièrement importante en sciences de la santé (171 millions), en sciences pures (166 millions), en sciences appliquées (122 millions) et en sciences humaines (42 millions).



As part of an effort to account for public funds spent on universities, the Québec government has published data on various aspects of university activity. The publication has both historical data on all universities in the province as well as on individual institutions, covering student and staff data, graduation and research information. For the Minister of Higher Education and Science, the endeavour brings to the fore the role of the

universities and the changes since the early 1970's. The statistical indicators cannot be said to measure quality or performance. To do so would require establishing standards against which the raw data would be compared. However, the information does provide a basis for further study and more refined analyses. The Minister expressed a particular interest in studies on registration rates by region, applications for admission, the transition rate from CEGEP to university, the average length of studies, program changes and withdrawals, joint programs, libraries and the average cost per programme and degree granted. Here are some of the highlights:

### **Changes in the student population**

Between 1971 and 1991 the number of male students increased by 80% whereas the number of female students rose by 325%. During the same period the percent of 18 to 29 year olds attending university went from 7.4% to 18.9%. More than 50,000 students graduate each year and 90% find work, though not always in areas linked to their studies. 82% of graduates with Master's degrees find work in their field whereas only 73% of doctorates are as successful.


### **Academic staff**

Between 1960 and the present the number of academic staff has grown from 2,350 to over 8,500. Their average age has risen from 39 to 47. One academic appointment in five is held by a female.

### **Research**

Funds for university research have grown fourfold between 1981 and 1991, going from \$141 to \$569 million. The federal government finances 37% of this amount, the provincial government 20% and the private sector 32%. The latter is a substantial increase from 12% in 1981. Research is concentrated in medical science (\$171 million) other sciences (\$166 million), engineering (\$122 million) and social sciences (\$42 million).

## New transfer credit policy for Ontario's universities



Following up on the Baker Commission report, which advocated freer, or "virtually equivalent" transfer credit policies among Ontario's universities, the Council of Ontario Universities (COU) has commissioned a group to examine ways and means of implementing a system-wide transfer credit approach.

The Transfer Credit Implementation Committee will be considering:

- a common policy guide for the transfer of course credit;
- common residence requirements for similar programs;
- equitable treatment of internal and external transfer credit;
- a common data base to be used as a transfer guide;
- the use of electronic data interchange (EDI).

Karen LeDrew, of the University of Waterloo, recently presented the Committee with an overview of the use of EDI to facilitate admissions and transfer credit processing. The presentation was warmly received and much follow-up work is planned.

The Committee's interim report is due before the end of the year. I'll keep you posted on their progress.

## Review of joint university liaison programs




The Ontario University Registrars' Association (OURA) recently announced the creation of a commission to review joint university liaison programs.

The review should help to ensure that OURA and the university sector continue to meet effectively the needs of their client groups through the most efficient management of liaison resources.

An interim report from the commission is due by year end.

## High school changes



Ontario's high school system has introduced "destreaming." Starting in September of this year, students entering grade 9 are no longer "streamed" into one of a basic, general, or advanced cohort. Some schools, funding permitting, may continue to offer the advanced stream.

While it is believed that there will be no immediate effect on Ontario Academic Credits (OACs), there is concern that an eventual watering down of the curriculum will occur as a consequence of the destreaming.

Destreaming may be extended to the grade 10 level and beyond if the experience with the grade 9 situation is found to be a positive one.

Ontario's Minister of Education has expressed support for standardized testing in High Schools. In an attempt to increase public confidence in the educational system, standardized reading and writing tests will be introduced to the grade 9 cohort this year. The tests are designed to target weaknesses and measure the system in non-pass/fail terms.

## Funding news



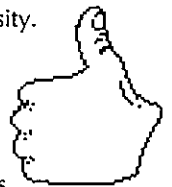
In June of this year the Ontario Government imposed a 5% reduction on grant payments to universities and colleges as part of their overwhelming "Social Contract Legislation." The legislation, effective until March 31, 1996, amounts to the equivalent of up to 36 days of unpaid leave over the three-year period for employees earning more than \$30,000 a year. In addition to the rollback in grant income, all salaries of over \$30,000 have been frozen until April 1, 1996.

Many institutions were able to partially offset the reduction in funding without having to resort to the full unpaid leave situation by dipping into pension surpluses and making greater sacrifices in other areas.

## Ontario's newest university



Lastly, and perhaps most importantly (from a strictly personal point of view), Ryerson Polytechnical Institute received a new charter and, as of June of this year, became Ryerson Polytechnic University, Ontario's newest university.



Coincidentally, Ryerson will play host to OURA's annual conference and workshops in February '94. ## ARUCC directory



The collaborative effort of the ARUCC Secretariat and the First Vice-President, Karen LeDrew, has resulted in a polished, crisp look to this year's ARUCC Membership Directory.

While the Secretariat provided updated membership information in response to the July appeal from Karen (for submission by August 15), Karen undertook to reformat the entire layout with a view to ease of use. In order to provide a comprehensive reference manual, she included a section on the Constitution and omitted other sections which appeared to have no practical value.

French translations were done by the Secretariat (with some assistance from staff at the Ontario Universities' Application Centre). These were forwarded to Karen on diskette so that bilingual information would be available for all relevant sections. Because of the cooperative approach taken to this project, as well as the adherence to strict deadlines, the Directory was produced in record time! Submissions from most member institutions were received by August 15 (a few trickled in up to the FINAL deadline of September 1); the Directory went to press on September 15; the job was completed September 30 (as projected) and delivered to the Secretariat for mailing to members on October 1.

Those institutions who missed out on sending in their revised information can get prepared to target next year's deadline when it is announced at the General Meeting! It goes without saying that effective communication among the membership will be better supported if the Directory information is reliable!

Karen is eager for feedback from ARUCC members about other revisions they might like to see included to make the Directory even more functional.

## Cross-Canada Report on EDI Activity



The 57 Canadian attendees at the SPEEDE/ExPRESS Workshop held in Vancouver October 17 to 19 made the most of the opportunity to share experiences and ideas on the EDI front!

It is clear, however, that more effective communication of ideas and representation of same is required (once a consensus has been achieved this side of the 49th parallel).

To assist in the communication process, Vic Chapman has set up an email discussion group. You may join this group by sending a message to: arucc\_edi-l-request@admissions.carleton.ca

There should be NO subject for the message and NO signature. In the first line of your message indicate: SUBSCRIBE arucc\_edi-l Your Name (for example, SUBSCRIBE arucc\_edi-l Karen LeDrew).

Thus far, representatives from all provinces or regions in Canada have signed onto the list and will soon be exchanging EDI information. Highlights of the activities currently underway across Canada include:

### British Columbia

- A successful pilot between the University of British Columbia and Simon Fraser University using the SPEEDE message standard and transmitting on a VAN (BCTel).
- A linkfile project is being funded by the BC Ministry of Education. UBC plans to send transcript data using EDI to the British Columbia Institute of Technology to support longitudinal studies on the progress of students through high school and post-secondary studies.
- The BC Registrars have passed a motion supporting transcript data exchanges using EDI.

- EDI is being considered for the BC post-secondary application centre when it is established.

### Alberta

- The TEDI project has been successfully completed using SPEEDE.
- Currently evaluating Supply Tech and SCT translation software

### Saskatchewan

High school grades have been successfully transmitted to the University of Saskatchewan and the University of Regina using a modified SPEEDE format. Both universities are considering the EDI transmission of transcripts.

### Manitoba

To date, EDI has been used primarily for purchase orders.

### Ontario

- A successful pilot project using SPEEDE message standard and transmitting via the Internet by File Transfer Protocol has been completed. (See the *Report from Ontario* this issue.)
- In November, an EDI Training Workshop will be held at Ryerson Polytechnic University for representatives from all Ontario universities
- There is also considerable interest in using EDI to support credit transfers among Ontario universities.

Hopefully, we'll hear news of developments from Quebec and the Maritimes in the near future! Let's look for more EDI workshops at ARUCC '94!!!!

## An EDI Client/Server for Internet



Given the existence of a message standard for communicating transcripts electronically (ANSI X12-Transaction set 130) and access to a common network, the Internet, an obvious application for EDI by educational institutions is the electronic interchange of transcripts. Currently, transcripts on the Internet are being transferred via two methods: email and FTP.

### Email

With email, transcripts are attached or included in a message and sent to another institution. Email is most nearly analogous to the manner in which paper transcripts are now exchanged between institutions and is vexed with the same inherent problems: the sender does not know if the transcript was received, and the receiver has no way of telling if the transcript was really sent by the sender indicated.

Another problem is that email messages can sit on intermediate hosts for an indeterminate period of time. And email is not particularly suited for sending large messages. (An EDI envelope containing numerous individual transcripts can easily amount to a 3MB file).

### File Transfer Protocol

Transcripts are sent and received between institutions using a File Transfer Protocol (FTP). Non-anonymous FTP used between two consenting institutions resolves some of the problems inherent with email in that the person initiating the FTP session must be able to log into the partner's computer system and have the appropriate access. This approach is excellent when there are a limited number of partners, but is not suitable on a larger scale involving numerous institutions.

A major problem inherent with both email and FTP is one of confidentiality. The Internet can easily be tapped and sensitive data like transcripts viewed by casual (unauthorized) users. And while encryption/decryption using email or FTP is possible, it also does not yet work well.

### EDICS

A proposed third option for transferring transcripts using the Internet is the EDI Client/Server aka EDICS. EDICS is a more specialized method of transferring transcripts that would resolve the problems inherent in either email or FTP. EDICS would consist of three main components: a Client, a Server and a Registry.

#### The EDI Client

This is a computer program which understands enough about the SPEEDE/ExPRESS protocol that it can extract the destination address from a transaction, and understands enough about the Internet that it can connect to the destination's EDI Server and transmit an encoded EDI transaction to it.

#### The EDI Server

This is a program which runs in the background on a computer connected to the Internet, and waits for a client to connect. When connected, it enters into a dialogue with the client, which results in the reception, decoding, and authentication of an EDI transaction.

#### The EDI Registry

Each institution wishing to make use of the services provided by the EDI Client/Server would have to register the institution's Server by providing the

Internet addresses of its server and the interchange sender ID (ISI) as per the SPEEDE/ExPRESS standard.

The Registry Service would provide for address resolution service similar to that of the NIC (National Internet Center). It would be capable of translating a given ISI into an Internet address, and would also maintain a system of keys used in the encryption/decryption process. The Registry Service could be operated by ACCRAO or its duly appointed agent.

When an EDI client or server wished to use the service, it would establish a TCP connection with the EDI Registry Server and obtain the Internet address for a given ISI.

NOTE: EDICS is currently being developed by La Cité Collégiale in conjunction with Carleton University, and is in the alpha-testing phase. Full-scale beta-testing is scheduled for December 1993.

## SPEEDE/ExPRESS 1993 Workshop Report



The SPEEDE/ExPRESS Workshop, held in Vancouver, British Columbia, October 17-19, and hosted by Simon Fraser University, was a tremendous success. Held in one of the most beautiful cities I have ever visited, the workshop also attracted the largest attendance we have had to date. A total of 268 people met to gather information and discuss the implementation of EDI as it pertains to student records. Fifty-seven Canadians attended as well as representatives of 32 states "south of the line."

Although the attendance from the pre-K through 12 sector was low, interest in all of the sessions was high. Evaluations ranked very high, with session 8.3, "Electronic Transcript Exchange: The SFU/UBC Way!" garnering the highest ranking of all. This was a demonstration of the Simon Fraser University/University of British Columbia electronic transcript exchange system using EDI and the SPEEDE/ExPRESS format on both PC and Macintosh platforms.

There are approximately 20 workbooks left containing the papers that session presenters had submitted in advance of the workshop. These 20 copies will be for sale for US\$50 from Betsy Bainbridge, AACRAO Office, One Dupont Circle, NW, Suite 330, Washington, DC 20036-1171, USA.

Both before and after the workshop proper, the SPEEDE Committee and the ExPRESS Technical Advisory Group met to discuss several issues, two of which may be of general interest to the SPEEDE/ExPRESS membership.

The SPEEDE/ExPRESS Strategic Plan has been finalized and has resulted in a lengthy document. Anyone interested in receiving a copy should contact Rich Hilpert, CCSSO at (202) 336-7054 or via Internet at [NRA.CU.HIH.GOV](mailto:NRA.CU.HIH.GOV). Copies are available at cost.

Also of interest was a lengthy meeting about the use of EDI over the Internet. Joining the Committees were David Crocker, a member of the Internet Engineering Task Force (IETF), and Kelly McDonald, a member of the WESTNet Board of Directors. In addition to speaking with the SPEEDE/ExPRESS Committees, both presented on their areas of expertise as part of the regular workshop program. David Crocker presented "Making EDI Over the Internet Pragmatic," which related Internet capabilities and possible courses of action for education's use of EDI over the Internet. McDonald's topic, "An Optimistic Future for the Internet," detailed the present controversy surrounding US government funding and commercial use. McDonald said that Internet's distributed management and sheer size will sustain its continued growth into the future.

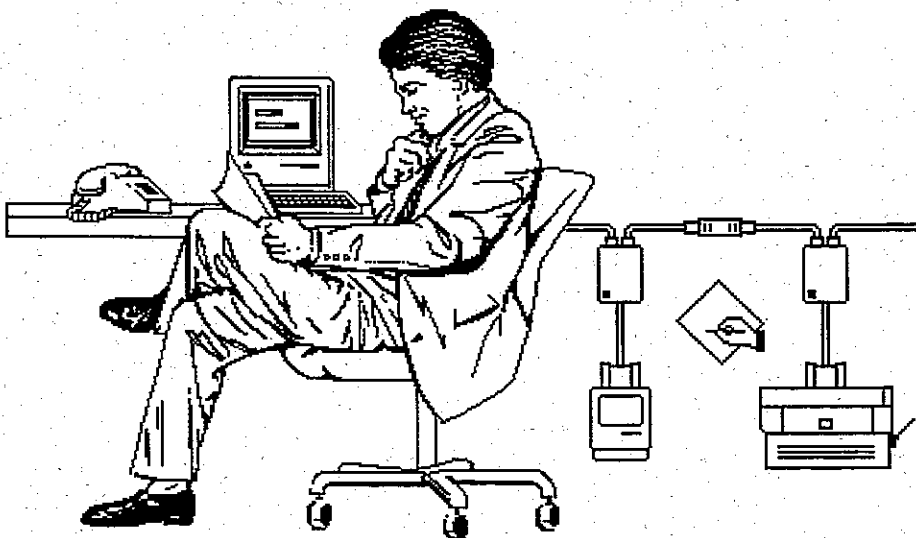
